Angelenos Take Traffic Safety Into Their Own Hands Amid City



Residents are increasingly stepping in to address traffic safety concerns as city bureaucracy lags behind urgent public needs. A recent example comes from the Sawtelle neighborhood, where volunteers painted crosswalks near Stoner Park after witnessing dangerous near-misses between pedestrians and vehicles. While local officials (including City Council Member Traci Park) praised the initiative, the Los Angeles Department of Transportation (LADOT) removed the markings within days, citing compliance concerns such as ADA accessibility and proper lighting. This incident exposes a broader challenge: despite ambitious city projects and safety programs, the city often struggles to implement even simple infrastructure improvements in a timely manner, leaving residents to take matters into their own hands.

The situation reflects a systemic issue called "state capacity," where government agencies have ambitious plans but insufficient resources, staffing, or streamlined processes to deliver them effectively. Even high-profile initiatives like the Vision Zero traffic safety program, transit expansion for the 2028 Olympics, and housing developments for homeless residents face delays, cancellations, and partial completions. For instance, only a fraction of planned transit projects and housing units have been delivered, and traffic fatalities continue to rise. While public pressure occasionally prompts corrective action, these ad-hoc fixes illustrate the urgent need for structural reforms to ensure Los Angeles can meet its residents' basic safety and infrastructure needs. **LA Times**¹

405 Freeway Weekend Closures Start Aug. 22



Caltrans is set to begin a previously announced \$150M project on the 405 through the Sepulveda Pass, reducing lanes to just three in each direction between Sunset and Victory starting Friday August 22nd. The partial closure, lasting on weekends through early 2026, will also involve multiple ramp closures at key interchanges, significantly impacting travel to and from Westwood, Santa Monica, Van Nuys, and the San Fernando Valley. Officials warn of major traffic delays and strongly urge drivers to seek alternate routes, use public transportation, or plan travel outside peak periods. The closures are part of an extensive repaving and modernization effort on one of the nation's busiest freeways, designed to improve long-term safety and efficiency but expected to cause heavy congestion in the short term. Councilmember Lee Launches Pilot Program to Fix Hazardous Sidewalks

Councilman John Lee has dedicated \$200,000 to launch his Street S.M.A.R.T. (Sidewalk Maintenance and Repair Team) pilot program, which will fix 20 damaged sidewalks in District 12, including Granada Hills. The initiative targets long-neglected hazards, often caused by tree roots, and uses small crews funded through Lee's office to provide faster and more cost-effective repairs. Residents have welcomed the improvements, and Lee says if the pilot proves successful, he will push to expand the program throughout the Northwest Valley. **ABC7**³

Los Angeles City Council Votes 8-5 to Oppose SB 79

The vote made official the city's formal opposition to Senate Bill 79, a statewide proposal that would require cities to permit mid-rise housing up to seven to nine stories within a half-mile of major bus and rail stops, even if local zoning currently restricts such development. Councilmember John Lee, who authored the council resolution, said, "The people of Los Angeles deserve to have a say in how their city grows," framing the bill as a significant overreach from Sacramento. Supporters of the resolution also claim that SB 79 would "hijack" local planning authority and ignore long-standing infrastructure limits, while critics argue that L.A.'s own sluggish and often cumbersome housing approval process has failed to meet the scale of the region's affordability crisis. Though largely symbolic, the vote highlights LA's and other cities ongoing pushback against Sacramento mandates, ultimately reflecting deep divisions on the issue. LAist4



<u>Poll Shows Californians Still Back High-</u> <u>Speed Rail Despite Doubts Over Completion</u>



A recent poll finds that 62% of California voters still back the state's high-speed rail project, even amid widespread doubt it will ever be completed, showing that enthusiasm for bullet trains remains strong. Support clearly breaks along partisan lines: 79% of Democrats remain in favor, compared to 55% of independents and just 38% of Republicans.

Despite steady backing, confidence in the project's eventual completion remains low, only around 1/4 of both Democrats and Republicans believe it will be finished. The project faces mounting obstacles; delays, ballooning costs, and a \$4 billion federal funding cut. Yet state leaders, including Governor Newsom and labor allies, propose using \$1 billion annually from California's capand-trade revenues to keep it alive and continue construction in the Central Valley as a foundation for future expansion. **Politico**⁵

Wider Bike Lanes Could Boost Emergency Response in LA

Councilmember Heather Hutt has introduced a motion (Council File: 25-0930) that would direct city departments to explore options for wider bike lanes that could accommodate emergency vehicles. The goal is to ensure fire trucks, police cars, and ambulances can navigate congested streets more effectively, improving response times and public safety. Well-designed bike lanes do not slow emergency vehicles and can actually improve response times by reducing traffic congestion. Additionally, bike lanes can include dedicated infrastructure, like wider lanes or bypasses, specifically to support emergency access, while also promoting safer, more efficient travel for cyclists.
